- Individuals must be 19 years of age or under as of December 31, 2013 and have performed their volunteer activity in the Community of Ancaster.
- Attach to form a description of nominee which includes, volunteer activities, age of nominee, school, leadership qualities and how long you have known the nominee
- Describe the nominee's experience(s) in a charitable/community enhancing activity
   \*A \$500 scholarship to the winner will be donated by the Ancaster Rotary Clubs

## THE ANCASTER HERITAGE HOUSEHOLD BUSINESS OF THE YEAR 2013

- Must be in business in the Community of Ancaster
- Must use, but not restricted to, criteria listed
- Will be judged on community involvement for the overall business or on a project/program basis. Must show commitment to the project/program (i.e. longevity of commitment, fundraising, etc.)
